 - □ **LaMonica Wiggins**: The minutes for our last meeting have been distributed to you via the TEAMS files. We need to approve the minutes. Are there any corrections? - IV. Updates from Community Relations Liaisons and Engagement Officers at Pitt
 - Jamie Ducar: 1. Number of events hosted recently including Sip and Stroll to support local business owners. Re-zoning hearing for Oakland crossings concept upcoming. The university wants to keep community needs in mind with a new dashboard. The Institutional masterplan public dashboard (IMP) will be live next year. The dashboard allows for

community members to review over 70 Pitt strategies and commitments for neighborhood enhancement – to see how we are investing in neighborhood quality through partnerships, programs like Pitt Serves and monetary commitments. The dashboard will be housed on community.pitt.edu. 2. The Concern Connection is a place where community can submit questions about development directly to the university. 3. Christmas day at Pitt is coming back in partnership with Salvation Army. Last held in 2019, served 2800 meals. Giving gifts to all children that attend. Will partner with the CECs and Pitt Athletics to collect gifts for the event.

- □ **Shenay Jeffrey:** Pitt Serves MLK Day update. Registration is open for staff, faculty and students to volunteer. Still looking for service projects. All projects need to be indoors.
- V. Updates from Community Pro-tem Members and Partners OPDC, OBID, Oakwatch, CHS, Peoples Oakland and OTMA
 - LaMonica: 1. People's Oakland Peoples Oakland continues to stay busy and well – a steady number of referrals are being processed by our intake coordinator, adding to our nearly 200 active members. On average, about 20 members per day attend PO to meet with their counselor, attend a group/activity, or socialize while distanced and masked. Thankfully, we have not had any COVID-19 positive cases, so we will continue with our current operating hours, Mon.-Thur. 9:30 am-5 pm and Fri. 9:30 am-4 pm. Our thanks in advance for the Holiday Dinner provided by Pitt and the Salvation Army. So many of our members are able to enjoy a delicious holiday meal on that day that otherwise would not, and for that, it absolutely makes a huge, positive difference we all appreciate so much. 2. OTMA – Port Authority is kicking off planning for the pedestrian crossing between Homestead Grays bridge and the McKeesport Transportation Center. The service improvements will include changes to the 61C bus route. Asking for feedback through a virtual public meeting happening today and again at 6:30 this evening. Mon-Oakland connector project is under review under the new mayor elect Ed Gainey. This project will be on hold pending internal review from administration and independent review from the controller's office. The Oakland Plan is seeking input on transit access via a survey (put link in chat).

Robin Kear: Last week we passed two policies and procedures – HIPAA policy and protection of child from abuse. Faculty Affairs also presented a document related to teaching and messaging for the spring.

- Updates on Senate Plenary
 - i. **Kris Kanthak**: March 1st will be the date of the Senate Plenary. Will be part of the Community Engaged Scholarship Forum. How will we

- highlight CES work around campus for newbees. Still working through what the event will look like with the Research Committee. We have funds to pay honorarium. Looking for ideas that will be helpful.
- ii. Jamie: For the Community Engaged Scholarship Forum, we are soliciting nominations and proposals. We are looking for workshops, lightning talks and more. Nominations are open for several awards related to community engagement, outstanding partnerships. The two headline topics that we are focusing on for this forum are: broader impacts and equitable practice. Our deep dives this year are Health equity, environmental justice and coalition building. These deeps dives align with the university's strengths. We are still bringing in partners and sponsors etc. The forum is 12 hours, and the Plenary would be impeded in this event.
- iii. **Kris**: The Plenary would be in a 3-hour block. We will have the attention of the Provost and Chancellor at that time. The structure of the event will be determined. We could have a panel, or keynote, hands-on activities etc. Looking to make this the most flexible and cost effective for everyone.
